## Awareness: OSINT is necessary



If you spend a minor portion of your time researching potential problems, verifying facts, and resolving unanswered questions, you can mitigate potential pitfalls.



This protects you from:

**Fiscal loss** 

Physical loss or damage

**Reputational damage** 

**Public scorn** 



An hour's worth of intelligence is better than 3 hours of investigations.

#### Consideration: Who is the audience?

Corporate executive trying to vet new candidate, vendor or supply chain

**Executive protection** looking to improve his risk intelligence

Investor trying to gain more knowledge about an ideal prospect

Leader needing greater intelligence about an unknown entity

#### **OSINT** for Corporate Executive

... trying to vet new candidate, vendor or supply chain

- Compliance is going to be a big part of their request, they will be resistant to all your upgrades
- Remove the OSINT jargon/acronyms and shop-talk.
- Consider business challenges that face your executives.
- Be sensitive of budget and be prepared to speak a financial language.
- Be clear about repercussions.

TIP

Spell out every detail in your proposal, and what your expectations are, even if you must spell out their expectations as well.

# Example message for Corporate

Problem: We recognize that you may have questions you need answered about the companies you work alongside or are considering partnering with. Vendors and suppliers should remain in compliance for your needs, and when they go astray, it may be your company name that feels the repercussion, or worse a mandated requirement goes unfulfilled. You may golf at their outings, the sales team may look great, their website is professional, but what do you really know about these businesses? Have you really looked at every article, social media post and financial detail? Can you see your brand name side by side with theirs?

Solution: We help with investigating any questionable partnerships, internal affairs, audit irregularities or mis-compliance actions.

#### **OSINT** for Investor

... trying to gain more knowledge about an ideal prospect

- Be mindful the investor may be speculating on a new market they have no knowledge.
- Or they are the absolute authorities and know all the key players.
- They have most likely done their homework and have entertained the target audience.
- Respect that legal, compliance, investigation, and audit leaders will have insight from different perspectives.

TIP

Respect your client and offer to 'check the boxes' 'dot the I's and cross the T's' while fortifying their research with your intelligence.



# Example message for Investor

Problem: As you take risk seriously, we try to conquer the most complicated of problems and questions well ahead of your key decision time. Your job is to find opportunity and advantage for your clients, and as you reach for these opportunities, we are behind you making sure you have the best intelligence and information at hand to understand the people, companies and industry you are examining.

#### **OSINT** for Executive Protection

... looking to improve his risk intelligence

- Know and speak to your audience. Are they security or business executive?
- Consider business challenges, and pushback, that face this professional.
- Often the protected individual resists being seen as vulnerable. You need to reassure discretion.
- Be sensitive of budget, maybe you start off small and grow your risk intelligence.

TIP

Be clear about repercussions including reputational damage and backlash if OSINT monitoring is not done.

## Example for Executive Protection

#### The Meditations By Marcus Aurelius



The fencer's weapon is picked up and put down again. The boxer's is part of him. All he has to do is clench his fist.

Marcus Aurelius reminds us in this metaphor is an emphasize on the Stoic idea that **true virtue and strength come from within**, from one's character and inner qualities, rather than relying on external tools or circumstances.

- We all love Google!
- Embrace the obvious, admit that as an OSINT Analyst, you use Google too. But your grasp of the deeper content, your access to the specialized and relevant databases, and your interpretation far exceeds Google's ability to offer up a word match.
- Analysis requires a focused search, specific to content with trusted resources.
- Google is trying to sell you luggage and rakes and vacations.

#### There is also more than Google!

- Public records government documents
- Online databases specialized services for content
- Web sites HTML pages with content
- Social media XML pages with content
- Surface web Results using a search engine
- Deep web or Invisible web non-searchable sites
- Dark Web non-directional content
- Photos and videos-metadata
- Geospatial information-maps, commercial imagery




